

**American Recovery and Reinvestment Act of 2009  
Byrne/JAG State and Local Law Enforcement Assistance, Non-Discretionary/Formula Grant**

**\$2 Billion** to support all components of the criminal justice system, from multijurisdictional drug and gang task forces to crime prevention and domestic violence programs, courts, corrections, treatment, and justice information sharing initiatives.

Existing program through Wyoming Attorney General's Office. Application required and distributed by formula (60% to states & 40% to local law enforcement)

Wyoming has prioritized that these federal funds sustain the DCI Regional Drug Enforcement Teams. Providing for Task Force Officers salaries and overtime costs reimbursed to local agencies. In addition, a portion of DCI Special Agent overtime costs have historically been covered under this grant, specific to violent crimes and drug investigations. DCI currently utilizes 32 Task Force Officers (TFO's) and has 37 DCI investigative case Agents.
